- e. SFS College, Nagpur shall explore the possibilities of supporting IT-NetworkZ in its learning and research requirement based on mutual convenience.
- f. To create awareness among member industries and students about the benefits of cooperation of understanding.
- g. The terms of cooperation for each specific activity implemented under the cooperation of MoU shall be mutually discussed and agreed upon in writing by both the Principal & member industry prior to the initiation of that activity.
- h. The members or the nominees of Board of Studies of Management shall interact at least four times a year to review the functioning or progress of programme.
- i. To update the curriculum of the programme time to time as per the need of the relevant industries in accordance with the guidelines of Sector skills and NVEQF.
- j. To collaborate for the conduct of joint projects like Trainings, Conference, Symposia, Seminars and Workshops.

WHEREAS

The SFS COLLEGE has decided to recognize IT-NetworkZ an approved Institution as decided by the Syndicate of the Board and to recognize to conduct various Industries/Job oriented para-professional courses under the approved institution of On campus/Off campus paraprofessional programme centers/Transfer of Technology and research programme centre in collaboration with ITZ.

The parties have had preliminary discussions in this matter and have ascertained areas of broad consensus. The parties now, have therefore, agreed to enter in writing these areas of consensus, under a Memorandum of Understanding.

Now this Memorandum of Understanding witnesses that: The IT-NetworkZ (approved Institution) shall offer the above listed training and Services as approved by the SFS COLLEGE for Department of Computer & Information Technology. The training fees of the respective courses may be fixed and revised as and when required by the mutual consent of the SFS COLLEGE and IT-NetworkZ (approved institution).

3. CONFIDENTIALITY

- a. During and for a period of Four years from the date of disclosure, each party agrees to consider as confidential all information disclosed by the other party in written or tangible form or, if orally disclosed confirmed in writing within thirty days of disclosure and identified as confidential by the disclosing party.
- b. The obligations above shall not extend to any confidential information for which the receiving party can prove that this information:
 - is in the public domain at the time of disclosure or comes within the public domain without fault of the receiving party.
 - is already known or become known to the receiving party
 - is received from a third party having no obligations of confidentiality to the disclosing party,
 - is required to be disclosed by law or court order.

4. NON-EXCLUSIVITY

The relationship of the parties under this MOU shall be nonexclusive and both parties, including their affiliates, subsidiaries and divisions, are free to pursue other agreements or collaborations of any kind. However, when entering into a particular agreement, the participants may agree to limit each party's right to collaborate with others on that subject.

5. TERMS AND TERMINATION

This MOU, unless extended by mutual written agreement of the parties, shall expire 5 years after the effective date specified in the opening paragraph. This MOU may be amended or terminated earlier by mutual written agreement of the parties at any time. Either party shall have the right to unilaterally terminate this MOU upon 60 days prior written notice to the other party. However, no such early termination of this MOU, whether mutual or unilateral, shall affect the obligations of the participants under any Agreement, Confidentiality clause as referenced in clause 3 above, or any other agreement entered into pursuant to this MOU, which obligations shall survive any such termination.

6. RELATIONSHIP

Nothing in this MOU shall be construed to make party a partner, an agent or legal representative of the other for any purpose.

7. ASSIGNMENT

It is understood by the Parties herein this MOU is based on the professional competence and expertise of each party and hence neither Party shall transfer or assign this Agreement, or rights or obligations arising hereunder, either wholly or in part, to any third party.

8. MISCELLANEOUS:

- a. The details for the efficacious implementation of this Memorandum of Understanding shall be jointly worked out on mutually acceptable terms within the parameters of the policies, rules and regulations of both the institutions.
- b. The parties to this memorandum may, by mutual consent, add modify, amend, delete, review or revise any term(s) and condition(s) of this agreement.
- c. The intent and implementation of this memorandum is **SUBJECT** to the policies of the respective states (in case of international agreements) and the laws of the land.
- d. The parties to this **MOU** undertake to treat as **CONFIDENTIAL AND PRIVILEGED** information of the other institution, which is so classified in advance. The terms of confidentiality and mode of disclosure shall be as per mutually acceptable terms.
- e. This MOU shall require the ratification of the competent academic/executive body of both the institutions.

9. COSTS OF THE MOU

Each Party shall bear the respective costs of carrying out the obligations under this MOU.

10. SIGNED IN DUPLICATE

This MOU is executed in duplicate with each copy being an official version of the Agreement and having equal legal validity.
